CLAUSE 1 - SCOPE OF THE CONTRACT

The Seller and Reseller, under full corporate authority and responsibility, respectively represent that one part is a lawful owner of the commodity in quantity and quality as hereunder specified, and the other has the full capacity to resell the said commodity, whereby the Reseller has the right to over control the cargo either in the sea or onshore, made available at any time under sales purpose, as the given authority shall include but not limited to: giving the instruction to Master or tank operator to direct or inject the cargo to the potential end discharge point; giving the right to transfer ownership in the way to make sure the final payment is effected to Seller/Reseller agreeable bank account.

CLAUSE 2 - COMMODITY

JET FUEL A1, JP54, D6, BASE OIL SN100, SN150, SN500, BASE OIL SN150, SN650, RUSSIA D2 GAS OIL GOST 305-82, RUSSIA EXPORT BLEND CRUDE GOST 9965-76, DIESEL EN590 10 PPM, 500 PPM, HSD2 GAS OIL L-0.2-62 GOST 305-82 AGO (AUTOMATIVE GAS OIL), LIQUIDIFIED NATURAL GAS, LPG, OCTANE 95, LCO, FERTILIZERS AND RAW/CRUDE ITEMS OR FINAL PETROLEUM/CHEMICALS VARIANT PRODUCT ACCESSIBLE TO THE SELLER TO OFFER AT ANY TIME, AND WITH AN OPEN QUANTITY.

CLAUSE 3 - QUANTITY

All Commodities on the above clause 2 and other commodities which may be in need in the future will be supplied in any requested quantity to the Reseller on credit to resell and deposit back payment to seller.

CLAUSE 4- SHIPMENT:

All commodities will be supplied to Any Safe World Port on CIF, FOB, TFO as requested by the reseller

CLAUSE 5 - INSPECTION:

Inspection at Port of Loading, will be conducted by SGS and paid by the seller
Inspection at Port of Discharge will be conducted by SGS and paid by the seller



CLAUSE 6 - DURATION OF CONTRACT:

One year contract with possible rolls and extension up to 20 years a head

CLAUSE 7 - IMPORT PERMISSION:

The Seller shall be responsible for the import permission, quotas and other necessary official import documents

CLAUSE 8 - CONTRACT FEE:

Five hundred thousand united state dollars on a one year contract, other contract below one year will be negotiated with seller.
